Note 1: 52,000 options (before adjustment) were exercised on 20 April 2010 and so 52,000 shares (adjusted to 312,000 shares after the bonus issue) were allotted on 6 May 2010.

Note 2: The exercise prices of the share options, the number of the exercised share options, the number of new shares issued during the month and the number of issuable shares under the exercise of share options have been adjusted pursuant to the bonus issue of shares (on the basis of five bonus shares for every one existing issued share held on 20 May 2010) approved by the shareholders of the Company at the annual general meeting on 20 May 2010.

Note 3: 200,000 options (before adjustment) were exercised on 30 April 2010 and so 200,000 shares (adjusted to 1,200,000 shares after the bonus issue) were allotted on 6 May 2010.

Note 4: 30,000 options (before adjustment) were exercised on 26 April 2010 and so 30,000 shares (adjusted to 180,000 shares after the bonus issue) were allotted on 6 May 2010. Therefore, the total number of new shares issued during the month under the exercise of share options at the exercised price of HKD0.373 (adjusted after the bonus issue) was 18,780,000 shares.

Note 5: 5,182,000 shares (before adjustment of bonus issue) were allotted before the bonus issue of shares.

Note 6: The bonus issue of shares was made on the basis of five bonus shares for every one existing issued share held on 20 May 2010.

Note 7: Total increase in ordinary shares during the month is 1,223,675,000 shares, based on 244,735,000 shares in issue immediately before the bonus issue mentioned above, in which 5,182,000 shares (before the adjustment of bonus issue) are allotted during the month under the exercise of share options.
