**INSIDE INFORMATION –
WINDING UP PETITION AGAINST A SUBSIDIARY OF THE COMPANY**

This announcement is made by Bonjour Holdings Limited (the “**Company**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on the Stock Exchange and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

On 8 December 2020, it has come to the attention of the Company that a winding up petition (the “**Petition**”) has been filed with the High Court of the Hong Kong Special Administrative Region (the “**Court**”) under action number HCCW 419/2020 on 7 December 2020 by Apexwealth Investment Limited (the “**Petitioner**”) against Bonjour Cosmetic Wholesale Center Limited (“**Bonjour Wholesale**”), a subsidiary of the Company, under the Companies (Winding Up and Miscellaneous Provisions) Ordinance (Chapter 32 of the Laws of Hong Kong) applying for the winding up of Bonjour Wholesale. The Petition will be heard before the Court at 9:30 a.m. on 10 March 2021.

The Petition was filed against Bonjour Wholesale on the principal ground that Bonjour Wholesale has failed to pay the amount of HK\$4,028,969.99, being the outstanding arrears of rent and air-conditioning charges/management fees, together with interest accrued thereon, under an alleged breach of a tenancy agreement with the Petitioner.

The board of directors of the Company (the “**Board**”) is in the course of seeking legal advice in relation to the Petition. So far as the Board is aware, up to the date of this announcement, the Petition has no material impact on the business and normal operations of the Company and its subsidiaries.

Further announcement(s) will be made by the Company to keep its shareholders and investors informed of any significant development of the Petition as and when appropriate.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
