UPDATES ON WINDING UP PETITIONS AGAINST A SUBSIDIARY OF THE COMPANY

This announcement is made by Bonjour Holdings Limited (the “**Company**”) pursuant to Rule 13.09 and Rule 13.25 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcements of the Company dated 26 July 2022 and 29 July 2022 (the “**Announcements**”) regarding (i) the winding-up petition filed by Daily View Investment Limited and Stead On Investment Limited against Hop Fung Lung Limited (formerly known as Bonjour Cosmetic Wholesale Center Limited)(“**HFL**”), a subsidiary of the Company (“**Petition 1**”); and (ii) the winding-up petition filed by Smart View Enterprise Limited against HFL (“**Petition 2**”, together with Petition 1, the “**Petitions**”), respectively. Unless otherwise defined, capitalized terms used herein shall have the same meanings as those defined in the Announcements.

At the hearing of Petition 1 on 28 September 2022, the Court has ordered that the said petition shall be adjourned to 19 October 2022 at 11:00 a.m. At the same hearing, Counsel for the abovementioned Smart View Enterprise Limited (being (i) a supporting creditor of Petition 1 and (ii) the Petitioner of Petition 2) indicated that Smart View Enterprise Limited would discontinue Petition 2 and the relevant parties thereto would enter into a consent summons to the effect that the hearing of Petition 2 originally scheduled on 5 October 2022 shall be vacated.

The Company will keep its shareholders and potential investors informed of any significant development of the Petitions and will make further announcement(s) as and when appropriate in accordance with the Listing Rules.

CONTINUED SUSPENSION OF TRADING

Reference is made to the announcement of the Company dated 19 September 2022 in relation to the resumption guidance for resumption of trading in the shares of the Company (the “**Resumption Guidance**”) as set out in the letter from The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) dated 15 September 2022 and the quarterly update on status of resumption.

At the request of the Company, trading in the shares of the Company on the Stock Exchange has been suspended with effect from 1:00 p.m. on 16 June 2022 and will remain suspended until the Company fulfills the Resumption Guidance.

The Company will keep its Shareholders and potential investors informed of the latest progress as and when appropriate and will announce quarterly updates on its development pursuant to the relevant Listing Rules.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
